### **DECISION AWARDING DAMAGES**<sup>1</sup>

### **Dorsey**, Chief Special Master:

On November 14, 2016, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleges that she suffered a shoulder injury related to vaccine administration ("SIRVA") following her October 6, 2015 influenza ("flu") vaccination. Petition at 1-2. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On April 13, 2017, a ruling on entitlement was issued, finding petitioner entitled to compensation for SIRVA. On July 10, 2017, respondent filed a proffer on award of compensation ("Proffer") indicating petitioner should be awarded \$60,000.00. Proffer at 1. In the Proffer, respondent represented that petitioner agrees with the proffered

award. Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, the undersigned awards petitioner a lump sum payment of \$60,000.00 in the form of a check payable to petitioner, Rachel Koenig. This amount represents compensation for all damages that would be available under § 300aa-15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.<sup>3</sup>

#### RESPONDENT'S PROFFER ON AWARD OF COMPENSATION
