DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

On November 15, 2016, petitioner filed a petition under the National Childhood Vaccine Injury Act, 42 U.S.C. §§ 300aa-10–34 (2012) ("Vaccine Act"). On February 16, 2017, the undersigned issued an Order Concluding Proceedings pursuant to Rule 21(a).

On May 19, 2017, petitioner filed a motion for attorneys' fees and costs. Petitioner requests \$4,762.50 in attorneys' fees and \$3,147.50 in costs for a total request of \$7,910.00. On May 22, 2017, respondent filed a response to petitioner's motion explaining he does not object to the amount sought by petitioner. Respondent notes that his lack of objection "should not be construed as admission, concession, or waiver as to the hourly rates requested, the number of

hours billed, or the other litigation related costs." Resp. at 1.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300 aa-15(e). Based on the reasonableness of petitioner's request and the lack of opposition from respondent, the undersigned **GRANTS** petitioner's application for attorneys' fees and costs.

Accordingly, the undersigned awards the total amount of \$7,910.00, as a lump sum in the form of a check payable jointly to petitioner and Gaylord Popp, LLC.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.²

IT IS SO ORDERED.
