### **RULING ON ENTITLEMENT**<sup>1</sup>

**Dorsey**, Chief Special Master:

On January 23, 2017, Devora Stamm (“petitioner”) filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,<sup>2</sup> (the “Vaccine Act”). Petitioner alleges that she received an influenza (“flu”) vaccine on March 8, 2016, and thereafter suffered from a shoulder injury that was caused-in-fact by the flu vaccine. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On September 26, 2017, respondent filed his Rule 4(c) report in which he concedes that petitioner is entitled to compensation in this case. Respondent’s Rule 4(c) Report at 1. Specifically, respondent “has concluded that a preponderance of the

evidence establishes that the injury to petitioner's left shoulder was caused-in-fact by the administration of the flu vaccine on March 8, 2016, petitioner's injury is not due to factors unrelated to the administration of the flu vaccine, and petitioner has suffered the sequela of her injury for more than six months." *Id.* at 2. Respondent further states that in light of the information contained in petitioner's medical records, he has concluded that petitioner has satisfied all legal prerequisites for compensation under the Vaccine Act. *Id.*

**In view of respondent's position and the evidence of record, the undersigned finds that petitioner is entitled to compensation.**

**IT IS SO ORDERED.**
