DECISION AWARDING DAMAGES¹

Dorsey, Chief Special Master:

On February 2, 2017, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleges that he suffered a left shoulder injury related to vaccine administration ("SIRVA"). Petition at 1-3. The case was assigned to the Special Processing Unit ("SPU") of the Office of Special Masters.

On August 25, 2017, a ruling on entitlement was issued, finding petitioner entitled to compensation for SIRVA. On December 12, 2017, respondent filed a proffer on award of compensation ("Proffer") indicating petitioner should be awarded \$95,000.00. Proffer at 1. In the Proffer, respondent represented that petitioner agrees with the proffered award. Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, the undersigned awards petitioner a lump sum payment of \$95,000.00 in the form of a check payable to petitioner, Joseph Lamonde. This amount represents compensation for all damages that would be available under § 300aa-15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.³

PROFFER ON AWARD OF COMPENSATION¹

I. <u>Procedural History</u>

On February 2, 2017, Joseph Lamonde ("petitioner") filed a petition for compensation ("Petition") under the National Childhood Vaccine Injury Act of 1986, 42 U.S.C. §§ 300aa-1 to -34, as amended. He alleged that, as a result of receiving the influenza ("flu") vaccine on October 6, 2015, he suffered a left shoulder injury related to vaccine administration ("SIRVA"). Petition at 1-3. On August 24, 2017, respondent filed his Vaccine Rule 4(c) report, conceding causation-in-fact for a SIRVA to petitioner's left arm. On August 25, 2017, the Chief Special Master issued a ruling on entitlement, finding that petitioner was entitled to compensation for a SIRVA to petitioner's left arm.

II. <u>Items of Compensation</u>

Based upon the evidence of record, respondent proffers that petitioner should be awarded \$95,000.00, which represents all elements of compensation to which petitioner would be entitled

under 42 U.S.C. § 300aa-15(a). Petitioner agrees.

III. Form of the Award

Respondent recommends that the compensation provided to petitioner should be made through a lump sum payment of \$95,000.00, in the form of a check payable to petitioner.² Petitioner agrees.
