RULING ON ENTITLEMENT¹

Dorsey, Chief Special Master:

On February 10, 2017, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. § 300aa-10, *et seq.*,² (the “Vaccine Act”). Petitioner alleges that she suffered pain in her left arm resulting from a pneumococcal vaccination (Pevnar 13) received on June 8, 2015. Pet. at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On August 16, 2017, respondent filed his Rule 4(c) report in which he concedes that petitioner is entitled to compensation in this case. Resp.’s R. 4(c) Rept. at 1. Specifically, respondent “believes that petitioner’s alleged injury is consistent with a shoulder injury related to vaccine administration (“SIRVA”) and that it was caused-in-fact by the pneumococcal vaccine she received on June 8, 2015. *Id.* at 4. Respondent

further agrees that no other causes for petitioner's SIRVA were identified, that petitioner has met the statutory requirements by suffering the condition for more than six months, and therefore that petitioner has satisfied all legal prerequisites for compensation under the Vaccine Act. *Id.*

In view of respondent's position and the evidence of record, the undersigned finds that petitioner is entitled to compensation.
