### **DECISION ON ATTORNEYS' FEES AND COSTS<sup>1</sup>**

On July 13, 2017, Jesse Martin ("Petitioner") filed a petition for compensation pursuant to the National Vaccine Injury Compensation Program.<sup>2</sup> 42 U.S.C. §§ 300aa-10 to -34 (2012). Petitioner alleged that he suffered from narcolepsy and cataplexy as a result of the HPV vaccination he received on August, 13, 2014, the HPV vaccination he received on August 18, 2016, or some combination thereof. *See* Petition, ECF No. 1. On August 11, 2021, Petitioner filed a motion for a decision on the record, and on August 20, 2021, the undersigned issued her decision dismissing the petition for insufficient proof. (ECF No. 81).

On February 16, 2022, Petitioner filed an application for final attorneys' fees and costs. ("Fees App.") (ECF No. 85). Petitioner requests total attorneys' fees and costs in the amount of \$78,136.90, representing \$67,265.00 in attorneys' fees and \$10,871.90 in attorneys' costs. Fees

App. at 1. Pursuant to General Order No. 9, Petitioner states that he has not personally incurred any costs related to the litigation of this matter. Fees App. Ex. 3. Respondent responded to the motion on February 20, 2022, stating that “Respondent is satisfied the statutory requirements for an award of attorneys’ fees and costs are met in this case” and requesting that the undersigned “exercise her discretion and determine a reasonable award for attorneys’ fees and costs.” Resp’t’s Resp. at 2-3 (ECF No. 86). Petitioner filed a reply on February 28, 2022, reiterating his belief that the requested amount for attorneys’ fees and costs was reasonable. (ECF No. 60).

This matter is now ripe for consideration.

## **I. Reasonable Attorneys’ Fees and Costs**

Section 15(e) (1) of the Vaccine Act allows for the Special Master to award “reasonable attorneys’ fees, and other costs.” § 300aa–15(e)(1)(A)–(B). Petitioners are entitled to an award of reasonable attorneys’ fees and costs if they are entitled to compensation under the Vaccine Act, or, even if they are unsuccessful, they are eligible so long as the Special Master finds that the petition was filed in good faith and with a reasonable basis. *Avera v. Sec’y of Health & Human Servs.*, 515 F.3d 1343, 1352 (Fed. Cir. 2008). Here, although the petition was eventually dismissed, the undersigned has reviewed the record and finds that the case maintained reasonable basis and good faith throughout the time the petition was pending. Respondent also has not challenged the good faith or reasonable basis of Petitioner’s claim. Accordingly, Petitioner is entitled to a final award of reasonable attorneys’ fees and costs.

It is “well within the special master’s discretion” to determine the reasonableness of fees. *Saxton v. Sec’y of Health & Human Servs.*, 3 F.3d 1517, 1521–22 (Fed. Cir. 1993); *see also Hines v. Sec’y of Health & Human Servs.*, 22 Cl. Ct. 750, 753 (1991). (“[T]he reviewing court must grant the special master wide latitude in determining the reasonableness of both attorneys’ fees and costs.”). Applications for attorneys’ fees must include contemporaneous and specific billing records that indicate the work performed and the number of hours spent on said work. *See Savin v. Sec’y of Health & Human Servs.*, 85 Fed. Cl. 313, 316–18 (2008).

Reasonable hourly rates are determined by looking at the “prevailing market rate” in the relevant community. *See Blum v. Stenson*, 465 U.S. 886, 895 (1984). The “prevailing market rate” is akin to the rate “in the community for similar services by lawyers of reasonably comparable skill, experience and reputation.” *Id.* at 895, n.11. The petitioner bears the burden of providing adequate evidence to prove that the requested hourly rate is reasonable. *Id.*

### **a. Reasonable Hourly Rates**

Petitioner requests the following hourly rates for the work of his attorney, Ms. Danielle Strait: \$340.00 per hour for work performed in 2019, \$370.00 per hour for work performed in 2020, \$395.00 per hour for work performed in 2021, and \$415.00 per hour for work performed in 2022; and for Mr. FJ Caldwell, \$367.00 per hour for work performed in 2017, \$385.00 per hour for work performed in 2018, and \$400.00 per hour for work performed in 2019. Fees App. Ex. 1 at 23. These rates are consistent with what counsel have previously been awarded for their vaccine program work, and the undersigned finds them to be reasonable herein. However, the records

indicate that Mr. Caldwell also billed 5.5 hours in 2019 at \$404.00 per hour, exceeding his typical hourly rate. The undersigned shall reimburse these hours at \$400.00 per hour, resulting in a reduction of \$22.00.

#### **b. Reasonable Hours Expended**

Attorneys' fees are awarded for the "number of hours reasonably expended on the litigation." *Avera*, 515 F.3d at 1348. Counsel should not include in their fee requests hours that are "excessive, redundant, or otherwise unnecessary." *Saxton*, 3 F.3d at 1521 (quoting *Hensley v. Eckerhart*, 461 U.S. 424, 434 (1983)). Additionally, it is well-established that billing for administrative/clerical tasks is not permitted in the Vaccine Program. *Rochester v. United States*, 18 Cl. Ct. 379, 387 (1989); *Arranga v. Sec'y of Health & Human Servs.*, No. 02-1616V, 2018 WL 2224959, at \*3 (Fed. Cl. Spec. Mstr. Apr. 12, 2018).

Upon review, the undersigned finds the overall hours billed to be reasonable. Counsel has provided sufficiently detailed descriptions for the tasks performed, and, upon review, the undersigned does not find any of the billing entries to be unreasonable. Respondent also did not indicate that he finds any of the billing entries to be unreasonable. Accordingly, Petitioner is entitled to final attorneys' fees in the amount of \$67,243.00.

#### **c. Attorneys' Costs**

Like attorneys' fees, a request for reimbursement of attorneys' costs must be reasonable. *Perreira v. Sec'y of Health & Human Servs.*, 27 Fed. Cl. 29, 34 (Fed. Cl. 1992). Petitioner requests a total of \$10,871.90 in attorneys' costs. Fees App. Ex. 2 at 3. This amount is comprised of acquiring medical records, the Court's filing fee, postage, and work performed by Petitioner's expert, Dr. Lawrence Steinman. All of these costs are typical of Vaccine Program litigation and are reasonable in the undersigned's experience. Petitioner has provided adequate documentation supporting the request. Accordingly, the requested attorneys' costs are reasonable and shall be reimbursed in full.

## **II. Conclusion**

In accordance with the Vaccine Act, 42 U.S.C. § 300aa-15(e) (2012), the undersigned has reviewed the billing records and costs in this case and finds that Petitioner's request for fees and costs is reasonable. The undersigned finds that it is reasonable to compensate Petitioner and his counsel as follows:

Accordingly, the undersigned awards a lump sum in the amount of \$78,114.90, representing reimbursement for reasonable attorneys' fees and costs, in the form of a check payable jointly to Petitioner and Petitioner's counsel of record, Ms. Danielle Strait, and to be forwarded to Maglio Christopher & Toale, P.A., 1605 Main Street, Suite 710, Sarasota Florida 34236.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court shall enter judgment in accordance herewith.<sup>3</sup>
