DECISION AWARDING DAMAGES¹

Dorsey, Chief Special Master:

On August 3, 2017, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleges that she suffered a shoulder injury related to vaccine administration ("SIRVA") after receiving an influenza ("flu") vaccination on September 8, 2015. Petition at 1-2. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On March 7, 2018, a ruling on entitlement was issued, finding petitioner entitled to compensation for SIRVA. On May 3, 2018, respondent filed a proffer on award of compensation ("Proffer") indicating petitioner should be awarded \$118,552.00. Proffer at 1. In the Proffer, respondent represented that petitioner agrees with the proffered

award. Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the attached Proffer, **the undersigned awards petitioner a lump sum payment of \$118,552.00 in the form of a check payable to petitioner, Martha A. Boudreau.** This amount represents compensation for all damages that would be available under § 300aa-15(a).

The clerk of the court is directed to enter judgment in accordance with this decision. 3
