DECISION ON ATTORNEY'S FEES AND COSTS¹

On August 31, 2017, Jared Sipes ("petitioner") filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleges that he suffered from Guillain-Barré syndrome ("GBS") as a result of an influenza ("flu") vaccine he received on October 6, 2016. (Petition at 1). On September 26, 2019, a decision was issued awarding compensation to Petitioner based on the parties' stipulation. (ECF No. 51).

Petitioner has now filed a motion for attorney's fees and costs, dated December 24, 2020, (ECF No. 56), requesting a total award of \$42,196.35 (representing \$24,415.40 in fees and \$17,780.95 in costs). In accordance with General Order #9 Petitioner filed a signed statement indicating that Petitioner incurred no out-of-pocket expenses. (ECF No. 56-7). Respondent did not react to Petitioner's motion for attorney's fees and costs.

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorney's fees and costs. § 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of **\$42,196.35** (representing \$24,415.40 in attorney's fees and \$17,780.95 in costs) as a lump sum in the form of a check jointly payable to Petitioner and Petitioner's counsel. In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk shall enter judgment in accordance with this decision.³
