## **DECISION AWARDING DAMAGES<sup>1</sup>**

## Dorsey, Chief Special Master:

On September 15, 2017, petitioner filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, et seq.,² (the "Vaccine Act"). Petitioner alleges that she suffered a shoulder injury related to vaccine administration ("SIRVA") as a result of her October 28, 2016 influenza vaccination. Petition at 1. The case was assigned to the Special Processing Unit of the Office of Special Masters.

On July 31, 2018, respondent filed a combined Rule 4 report and proffer on award of compensation ("Proffer") indicating petitioner should be awarded \$55,324.98, representing \$55,000.00 for petitioner's actual and projected pain and suffering and \$324.98 for petitioner's unreimbursable medical expenses. Proffer at 3-4. In the

Proffer, respondent represented that petitioner agrees with the proffered award. On July 31, 2018, a ruling on entitlement was issued, finding petitioner entitled to compensation for SIRVA. Based on the record as a whole, the undersigned finds that petitioner is entitled to an award as stated in the Proffer.

Pursuant to the terms stated in the Proffer, the undersigned awards petitioner a lump sum payment of \$55,324.98 (representing \$55,000.00 in compensation for actual and projected pain and suffering and \$324.98 in compensation for unreimbursable medical expenses) in the form of a check payable to petitioner, Sara D'Angelo. This amount represents compensation for all damages that would be available under § 300aa-15(a).

The clerk of the court is directed to enter judgment in accordance with this decision.<sup>3</sup>
