DECISION ON ATTORNEY'S FEES AND COSTS¹

On February 12, 2018, Susan Zinanni ("Petitioner") filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*,² (the "Vaccine Act"). Petitioner alleges that she suffered "injuries, including Shoulder Injury Related to Vaccine Administration ("SIRVA"), resulting from the adverse effects of an influenza ("flu") vaccination she received on January 25, 2017." (Petition at 1). On June 6, 2019, a decision was issued by the Chief Special Master

Dorsey awarding compensation to Petitioner based on the Respondent's proffer. (ECF No. 37).

Petitioner has now filed a motion for attorney's fees and costs, dated December 27, 2019, (ECF No. 43), requesting a total award of \$29,071.46 (representing \$27,916.10 in fees and \$1,155.36 in costs). In accordance with General Order #9 Petitioner filed a signed statement stating that she incurred no out-of-pocket expenses. (*Id* at 2). Respondent reacted to the motion on December 30, 2019 indicating that he is satisfied that the statutory requirements for an award of attorney's fees and costs are met in this case and defers to the Court's discretion to determine the amount to be awarded. (ECF No. 44). On December 31, 2019, Petitioner filed a reply requesting the Court award all fees and costs requested. (ECF No. 45).

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorney's fees and costs. § 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of **\$29,071.46** (representing \$27,916.10 in fees and \$1,155.36 in costs) as a lump sum in the form of a check jointly payable to Petitioner and Petitioner's counsel. In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk shall enter judgment in accordance with this decision.³

IT IS SO ORDERED.
