## **DECISION ON ATTORNEY'S FEES AND COSTS<sup>1</sup>**

On June 24, 2019, Anna Nasher filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*<sup>2</sup> (the "Vaccine Act"). Petitioner alleges that she suffered a shoulder injury related to vaccine administration caused by an influenza vaccine and/or a pneumococcal conjugate ("Prevnar 13") vaccine administered on January 10, 2018. (Petition at 1-3). On August 17, 2021, a decision was issued awarding compensation to Petitioner based on the parties' stipulation. (ECF No. 46).

Petitioner has now filed a motion for attorney's fees and costs, dated September 27, 2021 (ECF No. 50), requesting a total award of \$17,317.41 (representing \$15,434.00 in fees and \$1,883.41 in costs). In accordance with General Order No. 9, counsel for Petitioner filed a signed statement indicating that Petitioner incurred no out-of-pocket expenses. (Id. at 2). Respondent did not file a response.

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorney's fees and costs. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of \$17,317.41 (representing \$15,434.00 in fees and \$1,883.41 in costs) as a lump sum in the form of a check jointly payable to Petitioner and Petitioner's counsel. In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk shall enter judgment in accordance with this decision.<sup>3</sup>
