DECISION ON ATTORNEY'S FEES AND COSTS¹

On April 30, 2020, Daisy Parrish filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the "Vaccine Act"). Petitioner alleges that she suffered a shoulder injury related to vaccine administration resulting from the adverse effects of an influenza vaccination she received on November 8, 2018. (Petition at 1). On April 13, 2022 a decision was issued awarding compensation to Petitioner based on the parties' stipulation. (ECF No. 30).

Petitioner has now filed a motion for attorney's fees and costs, dated August 8, 2022 (ECF No. 35), requesting a total award of \$28,616.86 (representing \$27,838.30 in fees and \$778.56 in costs). In accordance with General Order No. 9, Petitioner filed a signed statement indicating that Petitioner incurred no out-of-pocket expenses. (ECF No. 35-3). Respondent reacted to the motion on August 9, 2022, indicating that he is satisfied that the statutory requirements for an award of attorney's fees and costs are met in this case, but deferring resolution of the amount to be awarded to my discretion. (ECF No. 36). Petitioner filed a reply on August 10, 2022, requesting the Court award all fees and costs requested in Petitioner's application. (ECF No. 37).

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorney's fees and costs. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of \$28,616.86 (representing \$27,838.30 in fees and \$778.56 in costs), as a lump sum in the form of a check jointly payable to Petitioner and Petitioner's counsel. Per Petitioner's request the check should be forwarded to Maglio Christopher & Toale Law Firm, 1605 Main Street, Suite 710, Sarasota Florida 34236. In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk shall enter judgment in accordance with this decision.³
