DECISION ON ATTORNEY'S FEES AND COSTS¹

On September 3, 2020, Felicia A. Vinson filed a petition for compensation under the National Vaccine Injury Compensation Program, 42 U.S.C. §300aa-10, *et seq.*² (the "Vaccine Act"). Petitioner alleges that she suffered a right shoulder injury related to vaccine administration, a defined Table injury, after receiving an influenza vaccine on October 11, 2017. Petition at 1, ¶ 2. On April 20, 2022, a decision was issued awarding compensation to Petitioner based on the Respondent's proffer. ECF No. 43.

Petitioner has now filed a motion for attorney's fees and costs, dated August 12, 2022 (ECF No. 49), requesting an award of \$10,380.36 (representing \$10,269.80 in fees and \$110.56 in costs). Petitioner also requests \$5,318.31 in fees and costs incurred by Petitioner's former counsel, Habush, Habush, & Rottier, S.C. *Id* at 1. In accordance with General Order No. 9, counsel for Petitioner represents that Petitioner incurred no out-of-pocket expenses. *Id* at 2. Respondent did not file a response to Petitioner's motion.

I have reviewed the billing records submitted with Petitioner's request. In my experience, the request appears reasonable, and I find no cause to reduce the requested hours or rates.

The Vaccine Act permits an award of reasonable attorney's fees and costs. Section 15(e). Accordingly, I hereby GRANT Petitioner's Motion for attorney's fees and costs. I award a total of **\$15,698.67** (representing \$10,380.36 in fees and costs incurred by Kraus Law Group, LLC and \$5,318.31 in fees and costs incurred by Habush, Habush, & Rottier, S.C) as a lump sum in the form of a check jointly payable to Petitioner and Petitioner's counsel. In the absence of a timely-filed motion for review (see Appendix B to the Rules of the Court), the Clerk shall enter judgment in accordance with this decision.
